## INDEX TO CUSTOMER INFORMATION BULLETINS

For the last few years the Office of Titles has been undergoing many changes in the need to continue to serve the public in an efficient, but speedy manner. Changes in procedures and changes in the services provided have been reported in the medium of the now familiar Customer Information Bulletin.

With the commitment of this Office to introduce legislative changes to cater for the demand within the community, the Office of Titles Practice Manual has not been updated since March, 1986. It is anticipated that if approved by Parliament, the Land Titles Bill, Amendments to Strata Titles Act, and a Villa Titles Act will require a complete re-write of the Practice Manual. In the meantime, any changes to the procedures should be indexed against the Practice Manual.

The Customer Bulletins are more than just amendments to the Manual. These are our way of keeping you informed of our new services to you and often incorporate changes suggested by customer liaison groups.

The first Bulletin issued on the 9th of March, 1988, and with this, the 31st Bulletin, it is appropriate to issue an index to the Bulletins. Should you have missed any of the issues a copy may be obtained from the Customer Service Centre.
