**INSTRUCTIONS**

1. If insufficient space in any section, Additional Sheet, Form B1 should be used with appropriate headings. The boxed sections should only contain the words "see page..."
2. Additional Sheets shall be numbered consecutively and bound to this document by staples along the left margin prior to execution by the parties.
3. No alteration should be made by erasure. The words rejected should be scored through and those substituted typed or written above them, the alteration being initialled by the persons signing this document and their witnesses.
4. Duplicate Crown Lease or where issued, the Duplicate Certificate of Title is required to be produced or if held by another party then arrangements must be made for its production.

**NOTES**

1. **DESCRIPTION OF AGREEMENT LAND**  
If the Registered Proprietor of the Agreement Land is not the proprietor of the fee simple interest in the title, for example a leasehold interest then the following should be included in this panel (ie. as to Lease H..... over Lot... on Plan ....) or refer to Deposited Plans depicting affected area of land contained in the title.  
Lot and Diagram/Plan/Strata/Survey-Strata Plan number or Location name and number to be stated.  
Extent - Whole, part or balance of the land comprised in the Certificate of Title to be stated. If part, refer to Deposited Plan depicting affected area of land contained in the title.

5. **TERM AND VARIATIONS**  
Term to be stated in years, months and days or as the case may be. State variation in the panel provided. State variations of the Plantation Interest hereon. Any variation contained within this instrument must comply with section 6(1) of the *Tree Plantation Agreements Act* – see section 104O of *Transfer of Land Act*. If none, show "nil".
6. **EXECUTION**  
A separate attestation is required for every person signing this document. Each signature must be separately witnessed by an Adult Person. The full name, address and occupation of witnesses must be stated.
