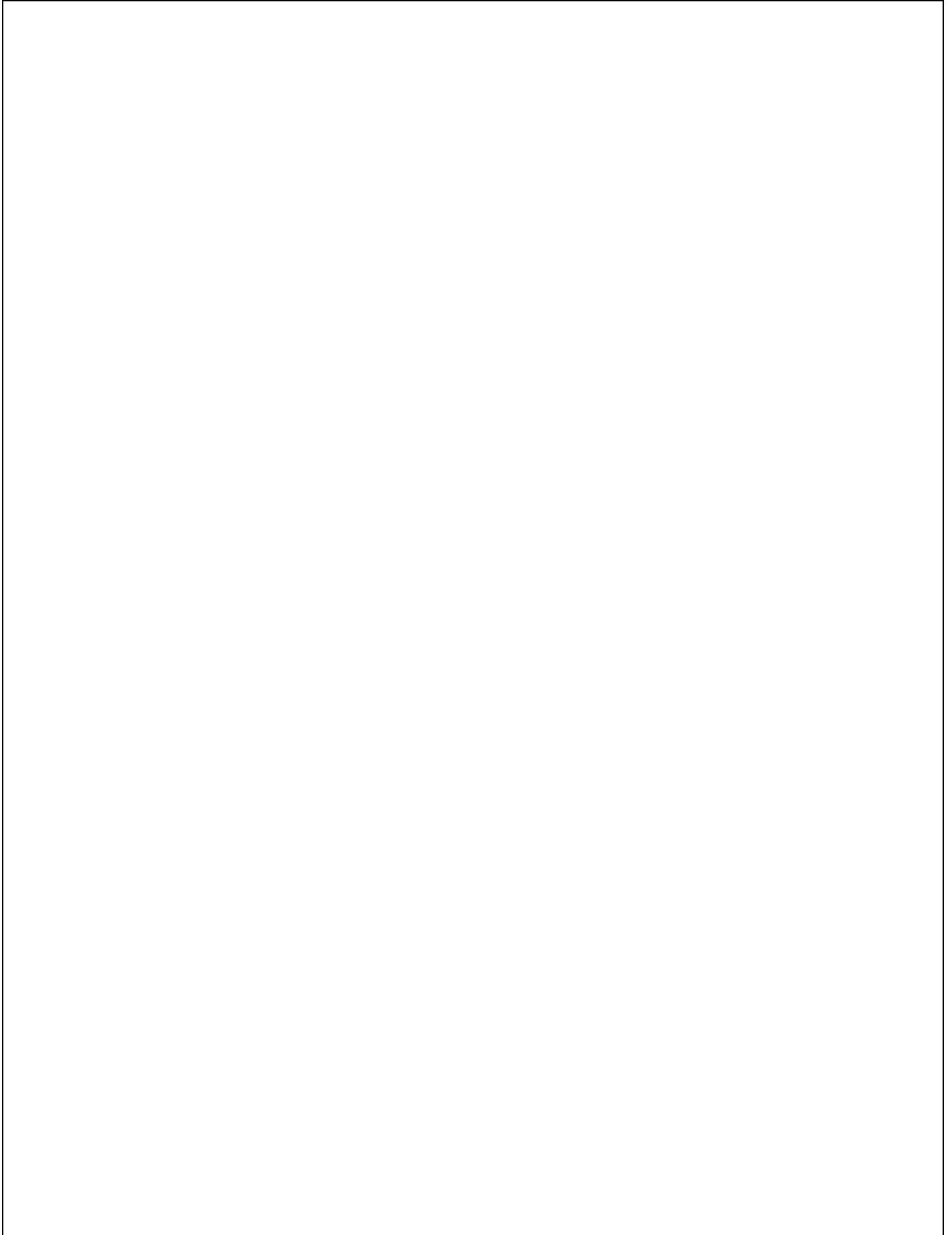

**INSTRUCTIONS**

1. If insufficient space in any section, Additional Sheet, Form B1 should be used with appropriate headings. The boxed sections should only contain the words "see page..."
2. Additional Sheets shall be numbered consecutively and bound to this document by staples along the left margin prior to execution by the parties.
3. No alteration should be made by erasure. The words rejected should be scored through and those substituted typed or written above them, the alteration being initialled by the persons signing this document and their witnesses.
4. If further Covenants or Memoranda of Provisions are to be shown or if insufficient space in any "Boxed Section" hereon page 2 should be used. Appropriate headings should be shown. The unused "Boxed Section" should only contain the words "see page . . . ."
5. Duplicate Crown Lease or where issued, the Duplicate Certificate of Title is required to be produced or if held by another party then arrangements must be made for its production. ***If a Duplicate Certificate of Title is not required to be re-issued, or if a Duplicate Certificate of Title has not been issued previously but is required to issue subsequent to this document, the written request of the Registered Proprietor is required by signing this panel.*** The option that a Duplicate Certificate of Title not be re - issued is only exercisable on a first Charge.

**NOTES**

1. **DESCRIPTION OF LAND**  
Lot and Diagram/Plan/Strata/Survey-Strata Plan number or Location name and number to be stated.  
Extent - Whole, part or balance of the land comprised in the Certificate of Title to be stated.  
The Volume and Folio or Crown Lease number, to be stated.
2. **ESTATE AND INTEREST**  
State whether Fee Simple, Leasehold or as the case may be in the land being charged. If share only, specify.
3. **LIMITATIONS, INTERESTS, ENCUMBRANCES and NOTIFICATIONS**  
In this panel show (subject to the next paragraph) those limitations, interests, encumbrances and notifications affecting the land being charged that are recorded on the certificate(s) of title:
  - a) In the Second Schedule;
  - b) If no Second Schedule, that are encumbrances.
 (Unless to be removed by action or document before registration hereof)  
  
Do not show any:
  - (a) Easement Benefits or Restrictive/Covenant Benefits; or
  - (b) Subsidiary interests or changes affecting a limitation, etc, that is to be entered in the panel (eg, if a lease is shown, do not show any sub-lease or any document affecting either).
 The documents shown are to be identified by nature and number. The plan/diagram encumbrances shown are to be identified by nature and relevant plan/diagram. Strata/survey-strata plan encumbrances are to be described as "Interests on strata/survey-strata plan".  
If none show "nil".
4. **REGISTERED PROPRIETOR**  
State full name and address of the Registered Proprietor as shown on Certificate of Title or Crown Lease and the address/addresses to which future notices can be sent.
5. **ANNUITANT**  
State full name of the Annuitant/Annuitants and the address/addresses to which future notices can be sent.
6. State the term of annuity. If for life use the words "During His/Her Lifetime".
7. State the times appointed for payment of the Annuity and any special covenants.
8. **REGISTERED PROPRIETOR'S EXECUTION**  
The Registered proprietor must sign this section of the Attestation Sheet. A separate attestation is required for every person signing this document. Each signature should be separately witnessed by an adult person. The full name, address and occupation of the witness must be stated.
