BULLETIN NO. 229 | 08 APRIL 2013 WESTERN AUSTRALIAN REGISTRAR AND COMMISSIONER OF TITLES JOINT PRACTICE: VERIFICATION OF IDENTITY

Full compliance with the Western Australian Registrar and Commissioner of Titles Joint Practice: Verification of Identity [1] commenced on 2 January 2013. Thank you for supporting the implementation of this Verification of Identity Practice.

The aim of this CIB is to assist property professionals to comply with the Verification of Identity (VOI) Practice by describing a range of matters that have arisen since the start of the year.

Using Australia Post as an Identifier

If a property professional wishes to subscribe to the Australia Post <u>WA land title transactions</u> service, they will need to contact Australia Post and arrange for the creation of Land Title Identity Verification Form that is bar-coded and unique to that property professional's service or business. Once this arrangement has been established and the property professional has their own unique bar-coded Land Title Identity Verification Form, they must tell their customers to only complete that specific form.

Landgate is frequently receiving VOI identification documents from Australia Post where the person being identified has used a Landgate bar-coded Land Title Identity Verification Form. This form is available from the Landgate website and is only relevant to **Self-represented Parties**, and is <u>not to be used</u> by those persons who are using the services of a conveyancer. Documents to which the VOI Practice applies

The following table clarifies the range of documents to which the VOI Practice applies. It is complementary to, but does not replace, Table 1 at 14.1.4 of the <u>Lands Title Registration Practice Manual (Edition 10.2)</u>.

[1] The Western Australian Registrar and Commissioner of Titles Joint Practice: Verification of Identity is known as the 'Verification of Identity Practice'.
